YOUR USE OF OUR WEBSITE, INCLUDING ANY DISPUTE CONCERNING PRIVACY, IS SUBJECT TO THIS PRIVACY POLICY. BY USING OUR WEBSITE, YOU ARE STATING THAT YOU UNDERSTAND, AGREE TO, ACCEPT, AND WILL USE THIS WEBSITE ONLY IN STRICT COMPLIANCE WITH THE RULES, TERMS, NOTIFICATIONS, WAIVERS, ACKNOWLEDGEMENTS, AND PRACTICES SET OUT IN THIS PRIVACY POLICY.

**Notice of Information Collected and Disclosed**

We may request information from you when you interact with our website, including when you:

- Log on to the areas of our website that require your user name and password as a condition to gaining access to the information, materials, or services in that area.
- Register or sign-up to subscribe to a service or to volunteer.
- Subscribe to a newsletter or ask to be added to our mailing lists.
- Obtain a product or service.
- Make a donation.
- Provide feedback in an online survey.

In connection with your use of our website, we may collect the following information:

- The domain name, but not the e-mail address, of visitors to our website.
- The e-mail addresses of users who communicate with us via the website or via e-mail.
- Aggregate information regarding the pages on this website accessed or visited by users.
- Information volunteered by the user, such as information provided if they register with the website which may include name, address, e-mail, phone, username, password, e-

mail address, language of use, time zone, update requests, information posted if you participate in any of our discussion boards, and general requests for information and other personal information.

- Information about your transactions with us.

Providing the voluntary data described above is at your sole discretion. If you submit personally identifiable information to us through the website, then we use your personal information to operate, maintain, and provide you with the features and functions of the website. We use both your personally identifiable information and certain non-personally-identifiable information (such as anonymous usage data, cookies, IP addresses, browser type, clickstream data, etc.) to improve the quality and design of the website and to create new features, functionality, and services by storing, tracking, and analyzing user preferences and trends.

CACGWT is the owner of the information collected on this website. The information is not collected for sale to third party marketers, and we do not sell or distribute the information collected from the website for commercial marketing purposes. Except as provided in this Policy, we do not disclose any nonpublic personal information about you to anyone except as permitted by law, however, we may choose to disclose all of the information we collect, as described above, to companies that perform services on our behalf such as data processors, technical systems consultants and programmers. We may also use the personal identifying information you provide to monitor usage and traffic-levels, analyze trends, administer the website, track user movement, gather broad demographic information for aggregate use, and to contact you regarding improvements we can make to our website and our services.

### **Personal Information**

You can visit [www.cactomgreen.org](http://www.cactomgreen.org) without telling us who you are and without revealing any information about yourself. However, to access certain portions of the website, you may have to submit information such as a user-id and password, or to access some services we provide, you may have to give us personal information such as your name, address, and e-mail.

### **Information Security and Quality**

CACGWT intends to protect the quality and integrity of your personally identifiable information.

We have implemented high grade encryption and the https security protocol to communicate with your browser software. This method is the industry standard security protocol, which makes it extremely difficult for anyone else to intercept sensitive data including credit card or financial information you send to us. Companies we work with to process credit cards and other financial transactions also use high grade encryption and security protocols.

It should be noted that information you elect to post to our website, e-mails, and other information you send to us, except that which you send us on a secure page, is not encrypted and such transmissions cannot be considered a secure means of transmitting sensitive information.

Accordingly, please always remember that transmissions on the Internet are not always

confidential. You are transmitting this information at your own risk. By accessing this website, you acknowledge that no data transmission over the internet can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, we cannot ensure the security of any information you transmit to or from this web site.

CACGWT will never ask you to submit your financial data, such as your credit card account numbers, via e-mail. Internet scams of this nature are often referred to as “phishing.” You should be aware of the limitations of security, authentication, encryption, and privacy measures used in connection with

the Internet and always be aware that any information you transmit through the website may be damaged, corrupted, "sniffed" and/or accessed by another person without your permission.

### **Website Traffic Information**

When you arrive at or leave www.cactomgreen.org, we automatically receive the web address of the website that you came from or are going to. We also collect information regarding the pages of our website you visit while you are on our hosted website, the type of browser you use, and the times you access our hosted sites. We use this information only to try to better understand visitor preferences and to manage the load on our servers.

### **Cookies**

A “cookie” is a small amount of data, which often includes an anonymous unique identifier, which is sent to your browser from a website's computer and stored on your computer's hard drive. Each website can send its own cookie to your browser if your browser's preferences allow it, but (to protect your privacy) your browser only permits a website to access the cookies it has already sent to you, not the cookies sent to you by other sites. You can configure your browser to accept all cookies, reject all cookies, or notify you when a cookie is sent. If you set your browser to turn off cookies some areas of some sites may not function properly.

We sometimes use cookies to collect non-personal information from visitors to our websites to help us provide better service and facilitate your visit to our website. We may use this data to analyze trends and statistics and to help us provide better customer service, but we do so in ways that keep the information anonymous. For your convenience, this website contains links or addresses to other websites. However, CACGWT is not responsible for the privacy practices or the content of any other websites. CACGWT does not share any of the individual personal information you provide us with to the sites to which we link, although we may share aggregate data with such websites (such as how many people use our site). We assume no liability for any unauthorized action of any third party or accidental transmission errors that may disclose information about you. CACGWT is not responsible for the content or privacy policies of other sites which may be different from our privacy practices.

### **Disclosure to Third Parties**

CACGWT understands the importance of privacy and confidentiality to users of this website. We will only share personally identifiable information with a third party if and when the individual submitting this information has permitted us to do so, or if we are required by law to do so. However, if you become involved in any violation of our security or rights, or the violation of any other party's security or rights, we may release information about you to assist in investigating, resolving, or pursuing redress for any such incidents. By accessing our website, you authorize us to disclose any information about you to law enforcement, government officials, or our attorneys as we, in our sole discretion, believe necessary or appropriate in connection with an investigation of fraud, intellectual property infringements, and violation of obligations to us under any agreement or policy, or any other illegal activity.

### **Children's Online Privacy Protection**

While little, if any, of this website is directed towards individual children, we are committed to comply with applicable laws and requirements, such as the United States' Children's Online Privacy Protection Act (COPPA).
